

# Ainslie Group Melbourne Cup Calcutta Terms and Conditions

**How to enter:**

Purchase Calcutta ticket(s) for \$1.00 per ticket

**Auction Date:**

Monday 6<sup>th</sup> November 2017

**Time:**

7:30pm

**Rules and Regulations:**

1. Members who have had their membership cancelled, suspended or have been excluded at the time of the Calcutta are ineligible.
2. The promotion is open to all financial members of the Ainslie Football and Social Club Limited that are eligible to enter. Members must be financial at the time of the draw. Members must be 18 years or over to enter this promotion.
3. The Calcutta will be drawn at the Gungahlin Lakes Golf & Community Club Gundaroo Road, Nicholls on Monday 6 November from 7:30pm.
4. Each draw will be random using a horse number/name in conjunction with a raffle ticket.
5. Tickets cost \$1 each.
6. Ticket holders who have not paid up prior to the draw are not eligible to participate in the draw.
7. The auctioneer will auction the longest priced (odds) horse to the shortest priced (odds) horse.
8. A progressive total of the pool will be announced periodically.
9. All payments are to be settled at the conclusion of each individual sale.
10. The drawer of a horse retains a half share; the remaining half is sold to the highest bidder. In the event of a horse being placed 1<sup>st</sup>, 2<sup>nd</sup> or 3<sup>rd</sup> he/she shares the prize money with the buyer.
11. The bidder shall pay the final bid, which is added to the prize pool. What you bid is what you pay.
12. The drawer of a horse may sell his/her share. In this case the drawer keeps half the bid, the other half goes into the pool. The buyer then becomes the outright owner of that horse.
13. There is no refund for horses scratched after the auction.

**Prizes:**

1<sup>st</sup>: 70% of the prize pool

2<sup>nd</sup>: 20% of the prize pool

3<sup>rd</sup>: 10% of the prize pool

**Redraw Policy:**

14. If a drawer of a horse is not present and there are no instructions to the contrary a half share will be sold and the drawer retains his/her share.
15. Members do not need to be present to be eligible to claim a prize.

**General:**
